a. WCCE 2021

She will lead a publication based on this and anyone who has responded to the email would be listed as an author.

d. Special issue

It will need a focus. We could discuss this on the email list. The focus will determine the journal. It's unclear whether it could be a closed special issue (which many journals do not support) or an open call. Raymond suggested that Artificial Intelligence and Education could be a focus. Mary suggested a focus on machine learning with papers on this topic for WCCE followed by a special issue. A number of people expressed interest.

ACTION: Mary Webb to lead on this and take to WCCE and see where it goes from there.

Raymond suggests that work from WCCE be taken forward to EDUsummIT.
